Re: <u>AMENDMENT TO DECEMBER 1, 2008 "F"-CLASSIFICATION FILING</u> <u>BUREAU FILING NO. 0808</u>

As previously announced in Bureau Circular No. 838, the Bureau submitted a rating value filing on August 8, 2008 for Delaware "F"-Classifications with a proposed effective date of December 1, 2008.

An error has subsequently been identified on Line 3 of Exhibit 1 of the filing materials. In order to correct the captioned filing for the effects of that error, the DCRB has amended Exhibits 1, 2, 8, 9, 11, 12, 15 (including the Class Book) and the Filing Forms previously filed in conjunction with Bureau Filing 0808.
