DCRB CIRCULAR NO. 995

To All Members of the DCRB:

Re: **SUBMISSION OF TEMPORARY STAFFING RATE FILING**

The DCRB submitted Filing No. 2102 (the Filing) to the Delaware Department of Insurance on April 13, 2021. It proposes to revise the current methodology used to calculate workers compensation residual market rates and voluntary market loss costs for temporary staffing risks in Delaware. A detailed discussion of the revised methodology is provided in the Actuarial Memorandum and exhibits included in the Filing.

The filing introduces a new methodology which eliminates the current 29 temporary staffing class codes and creates 289 new temporary staffing classes with each direct employment class mapping to one and only one temporary staffing class.

The Filing proposes no overall average change in collectible rate level compared to the approved rate level in Filing No. 2007, the December 1, 2020 Rate and Loss Cost Filing, prior to application of the loadings for the Delaware Classification Premium Adjustment Program (DCCPAP), Merit Rating Plan off-balance and Workplace Safety Program credits.

Policies issued with effective dates on and after December 1, 2021 must be qualified as carrying tentative rates, and the Pending Rate Change Endorsement is to be used for this purpose. Note that such policies issued at current rates or on a "to-be-determined" basis must be endorsed subsequently with the new carrier rates.

A table including the approved temporary staffing rates effective December 1, 2020, the proposed December 1, 2021 temporary staffing rates and the percentage change in rates by risk classification is attached. All rates in the attached table include Merit Rating Plan credit offsets and proposed Workplace Safety Program credit offsets. Construction classification rates also include DCCPAP loadings.
